INTRODUCTION



"Any believable prediction of the future will be wrong. Any correct prediction of the future will be unbelievable." This statement is perhaps the best reflection of the times we live in. The world had a hopeful start to 2021 with an approved vaccine, and witnessed one of the fastest global deployments of the vaccine to millions of people around the world. This was a year that we had all hoped we could return to the business as usual and back to the "way we were". The Sankalp team was eager to convene the Sankalp community in person as always, but we took a call to remain as a virtual summit given the devastating impact of the second wave in India & across the world. The decision to convene in person or not was a challenging one to take and it was impossible for any of us to take this decision lightly. We knew that our priority would always remain the health and well-being of our community and the broader ecosystem.

As we learned the contours of organizing virtual summits, and more importantly creating value for our participants, we are extremely grateful to all our partners who joined us in this journey. We are ever grateful to the **292 speakers, including 2 Nobel Laureates, 10 program partners, and the 2521 participants who joined us from 104 countries** across the world for the 2021 summit on "Mainstreaming Impact".

A big thank you to our partners for this year including the **International Finance Corporation** (IFC), Bop Inc, USAID Samridh, British Asian Trust, Cartier Women's Initiative, O Farms, Energy Catalyst, & Bayer Foundation. In addition to this we also had the support of several Friends of Sankalp who supported the outreach & amplification of the summit. We had 29.2 million impressions for the Global Summit! This year we also hosted our 2nd Private Equity Conference "Rendezvous" for growth stage enterprises; as well as the 3rd Edition of the CAIF conclave on circular textiles & apparels at Sankalp.

We retained our core purpose of convening to create an ecosystem of support for entrepreneurs around knowledge, capital & networks. We hosted **58 knowledge sessions** across core thematic areas financial services, climate change, gender & livelihoods, WASH, agriculture, circular economies, impact investing, & future of work; with cross cutting themes of women, capital & technology. In addition, we had over 25 booths that showcased innovations, & partners in our exhibition area. Our endeavor always was to maintain a balance of gender, & diversity to our panels with a strong focus on bringing out the voice of the Global South.

One of the key highlights of the summit in 2021 was the **8 moderators** from mainstream & independent media who helped us navigate the conversations this year – this included BBC, CNBC, CNBC Awaaz, Forbes, IDR, & India Spend.





Our Sankalp Awards remain the coveted "Oscars" of the impact world with **257 entrepreneurs** applying this year. To narrow down to the best of the best, we hosted two investor screening committees, & a prestigious Grand Jury to select **5** global award winners. This year, we also introduced a new ecosystem award and had **94,000 voters** help us choose our first awardee! Many of our Award winners & semi-finalists have gone on to raise significant funding to help scale their businesses from their engagements at Sankalp. Overall, we hosted **2855 hours of networking**, & facilitated **956 one on one meetings** at the Summit. We recognize that virtual meetings may not be ideal, but the ability to be inclusive, cost effective, and the scale it affords is of tremendous value to entrepreneurs as well as investors. We also hosted dedicated Deal Rooms between investors to meet other investors; investors to entrepreneur deal rooms, as well as a specific Female Founders Deal Room. Taking it a step forward, at Sankalp we also hosted our **2nd Private Equity Conference "Rendezvous"**; which facilitated **85 one on one meetings between entrepreneurs who were looking to raise upwards to \$5 Million with potential investors**.

In this report you will find highlights of the summit, as well as some key initiatives, and numbers related to the summit. Our agenda, & speaker lists can also be downloaded as annexures. The real value of a virtual convening is that every session is recorded and the tremendous knowledge repository remains as a digital asset for anyone to access on our YouTube page.

We remain committed to building an ecosystem of support for the Global South and welcome you all to this journey along with us.



GEOGRAPHIC REACH

This year at the Sankalp Summit, audiences from 104 countries attended through both our virtual platform and our live stream sessions via Facebook. The attendees were from diverse sectors working on creating social impact in their respective communities. We received major participation from India, Kenya, Bangladesh, the United States, the United Kingdom, Nigeria, the Netherlands, and the United Arab Emirates.

SANKALP GLOBAL SUMMIT 2021 THEME: MAINSTREAMING IMPACT

As we continue to navigate this pandemic that has transformed our lives across the world, the imperative for businesses, corporations, governments & individuals to pivot to an impact-driven economy has never been more urgent. Leading with an impact focus is, now not a "good to do thing" or an afterthought but, is smart economics that can solve the world's most pressing challenges.

The current pandemic has uncovered the inequities in the Global South whose vulnerable populations, and urban megacities have struggled with the basics of access to healthcare, food, water, jobs, migration, etc. Rural populations have struggled with the connectivity and the increasing digital divide that has thrown millions of children out of formal education (and unfortunately more girls). Millions of women across the world have disproportionately lost jobs & livelihoods and have been victims of violence. While the UN SDGs have given us the global grammar as a collective pathway to change, to put them into action, we need scalable and sustainable solutions, and mainstream capital to change the direction of their investments. The capital pivot requires a shift from investing in entrepreneurs whose goals are "cheaper, faster, more", towards entrepreneurs who are purpose-driven to be inclusive and focused on clean air, clean water, clean land. Impact investing now needs to be mainstream, rather than niche portfolios in the development sector.

Every year at Sankalp, we convene for-profit entrepreneurs that are driven by purpose, and the ecosystem needed to support them to thrive. We convene to solve for & with the emerging 3 billion in the Global South around the challenges of the climate crisis, smallholder farmers, sustainable agriculture, financial inclusion, livelihoods, water, health & sanitation. Across all of our thematic areas, we look at the role of technology, capital & women as cross-cutting themes. This year we also explore nature-based solutions, as well as circularity across different verticals.

We have an opportunity for a smart economic recovery across the Global South that can lead to a sustainable and equitable world. Our call to action at Sankalp this year is for investors, businesses, and governments across the world to lead with impact.





THEMATIC AREAS



INCLUSIVE FINTECH & FINANCIAL SERVICES

Globally, 2 billion people are financially excluded, and around 200 million micro, small, & medium enterprises have little to no access to credit. We will host conversations to improve access to finance for last-mile consumers by bringing forward innovative technology partnerships & improving product affordability. A special focus this year will be on inclusive fintech that has been a game-changer in bringing donations and cash benefit transfers to the last mile. The need to digitize rural value chains is even more urgent now to bridge traditional physical financial transactions that are limiting in scale. We will also look beyond credit to examine micro-investing, micro-savings, & micro-insurance for millions of low-income women. There is a wide use case for Fintechs to play a pivotal role in the gig economy, agri-insurance, & health insurance. Connecting entrepreneurs to collaborate across borders, & sectors is a key aim.



HEALTHCARE, WATER & SANITATION FOR BILLIONS

COVID-19 has exposed the inadequate access to healthcare across the world - even in developed countries. The enormous pressure this unprecedented pandemic has put on the medical facilities and frontline health workers has been unimaginable. However, what we have also seen is innovative delivery methods to the last mile, cutting-edge technology (3-D printing), and access to training for millions of healthcare workers. Healthtech entrepreneurs in the Global South have been at the forefront of innovation but need a more enabling ecosystem to scale. We will also host conversations around the lack of access to







water, adequate nutrition & sanitation that has deepened this crisis for vulnerable populations, and the solutions that entrepreneurs can offer for the emerging 3 billion.

GENDER LENS INVESTING, & WOMEN LEADERS

Women across the world have faced a disproportionate impact of the pandemic. While access to healthcare, technology, telephony, and education have dramatically improved for women, the same cannot be said for the current condition many women face in much of the developing world. Women may make up 70% of the world's impoverished (UN), but continue to be at a disadvantage despite the social and technological advances brought about for the bottom of the economic pyramid in the last few decades. Gender is a cross-cutting theme and will feature in all thematic sectors.

As always, we will host also an exclusive gathering for the #WomenatSankalp - celebrating & connecting women leaders.



AGRICULTURE - INCREASING RESILIENCE OF SMALLHOLDER FARMERS

Agriculture in the Global South is facing a plethora of challenges today, the results of which are likely to be extremely grave in the future, especially for smallholder farmers. Some of these challenges include soil and resource degradation, fragmentation of landholdings, dismal gender roles, and climate change; all of which impact the farmer. The Agriculture Track at Sankalp Global Summit has, hence, been designed as a step to support smallholder farmers' transit to practices that will increase their resilience, sustainability, and profitability, while being aligned to SDG 2 and SDG 12, simultaneously.







CLIMATE CRISIS - FINANCE, RISK, & OPPORTUNITY

The link between the current pandemic & potential disasters that are accelerated by unchecked climate change is now not a debate. We have seen how the poorest across the world are bearing the worst impact of the pandemic both in terms of health and economic instability. The impact of climate change on vulnerable communities will be devastating. To tackle climate change, all actors of the economy have to participate equally. This year, at Sankalp we look at engaging financial institutions & the private sector.

We will host conversations on climate risk pricing for financial institutions, blended finance vehicles, access to climate financing for MSMEs & the need to leverage private sector capital for on-the-ground solutions. We will also host conversations around offgrid & decentralized renewable energy stakeholders to increase their capacity & potential to scale across markets. Further conversations will address corporate ESG ratings for the private sector that can help drive the world to a low carbon economy.



CIRCULAR ECONOMIES

COVID-19 started as a health crisis but quickly turned into a humanitarian one. With 60 million people employed in the textile value chain, we wondered about the impact on these humans—artisans, workers, women, and other communities. Further to this, the textile & apparel industry is the 2nd most polluting industry globally and we want to change this. How do we build a bridge between the private sector & innovative entrepreneurs who can enable a circular economy?

Principles of circularity can also be applied to various sectors including agriculture, consumer goods & manufacturing. We will look beyond the textile industry to how the circular economy can help shape the impact economy in emerging economies.







IMPACT INVESTING, BLENDED FINANCE, & COLLABORATIVE PHILANTHROPY

Despite the global rise of impact capital, the availability of capital for innovation, early-stage ideas, and enterprises still represent less than 5% of asset allocation. Even though the startup and enterprise conversations dominate the public discourse, most impact capital is chasing large deals, and startups and innovators are only a small part of investors' portfolios. What can we do to channel more capital into funding innovation and early-stage ideas and enterprises?

We also will host conversations on blended finance as one of the options to bridge the SDG financing gap. It has been agreed in the development world that if it is possible to tap private financing into the already available development financing options then it is possible to bridge the financing gap. How then is it possible to leverage mainstream capital towards impact investing? What models have been adopted by various financiers in an effort to embrace the concept of blended financing? Further to this, collaborative philanthropic funding models have been effective in driving change at scale. What are the various models that have worked across the globe? This Sankalp, we will broaden the conversation to connecting capital for impact.



THE FUTURE OF WORK(ERS) & GIG ECONOMY

Pre-COVID we tackled globalization, automation, & celebrated gig economy work when discussing livelihoods & jobs. As we navigate a new normal, conversations have shifted to WFH, localized manufacturing, & hyper-local markets. Job security for gig economy workers, securing the livelihoods of migrant workers, and steady labour supply for MSMEs are now top of mind. An adequate supply of jobs is the bedrock for sustained prosperity, inclusion, and social cohesion in emerging economies.





What will the future of work look like for the millions of low-income workers across the Global South? Can technology & mobile connectivity bridge the gap for labour supply & demand, especially for micro & small enterprises?

At Sankalp this year, we will also bring you voices from the community so we listen to the voices that matter.

CROSS-CUTTING THEMES INCLUDE:

While the thematic verticals that we host allow us to deep dive into particular subject areas, we aim to emphasize the cross-cutting roles of women, capital & technology across all of our sessions. These are three enablers, as well as essential areas that we believe to be critical to bringing equity, & scale to the areas that we work in.







GLOBAL PERSPECTIVES FROM LEADERS




















SANKALP GLOBAL SUMMIT 2021 AGENDA

MAINSTREAMING IMPACT - A GLOBAL PATHWAY TO AN INCLUSIVE, GREEN RECOVERY

Keynote Address Nobel Peace Laureate, Kailash Satyarthi: "Leaving no child behind"

Kailash Satyarthi is a tireless advocate of children's rights globally and has led the global fight for children's rights for more than four decades. Through his organisation Bachpan Bachao Andolan, he has directly rescued more than 100,000 children from child labour, slavery, trafficking, and other forms of exploitation. The Global March Against Child Labour, which he led, galvanized support in 104 countries resulting in the adoption of ILO Convention 182 on the Worst Forms of Child Labour, which became the only universally ratified convention in the history of the ILO in 2020. In 2014, he was awarded the Nobel Peace Prize for his lifetime of struggle against the exploitation of children and young people and for the right of all children to education. This UN International Year for the Elimination of Child Labour, he has launched the global Fair Share to End Child Labour Campaign through the Kailash Satyarthi Children's Foundation and Laureates and Leaders for Children. The campaign addresses the inequality, injustice, and discrimination that lie at the core of child labour. As recognition for his leadership, the UN Secretary-General appointed Mr. Satyarthi as an SDG Advocate this year. He has dedicated his life to realizing his vision of ending violence against children and building a world where every child is free to be a child.

DAY 2, 13TH OCTOBER 2021

WOMEN LAND RIGHTS FUNDING ECOSYSTEM - STATUS, OPPORTUNITIES AND ROAD AHEAD

This session seeks to deliberate on potential strategies that would expand availability and access to finances - investments and grants - for women's land and property rights (WLPR) initiatives and enterprises in the 'not-for-profit' and 'for-profit' space. Despite evidence of better WLPR leading to equitable and sustainable developmental outcomes and India's gender-equitable legal framework, funding to improve WLPR in the record and on the ground remains limited, not only from Government but also from corporates and donors. This session would discuss pathways to improve availability to finances to WLPR initiatives and enterprises to move the needle forward towards the achievement of SDG, and if and how potential business-led solutions, including technology innovations, can help this. The session will deliberate on the scope and challenges of technology innovations esp. around recent developments in big data analytics, Al & ML, and geospatial tools that can scale up WLPR numbers at speed. It will also touch upon other strategic pathways that can expand finance, actors, and engagements around WLPR. It seeks to engage with DFIs, multi and bilateral donors, philanthropists as well as WLPR organizations working at policy, practice, entrepreneurship, and academic interfaces to assess the status, check potential and catalytic options, and build consensus on the right way forward.

THE CARE ECONOMY: ROLE OF SOCIAL FINANCE IN PROMOTING GENDER EQUITY

Paid and unpaid care and domestic work which constitute the care economy are vital to society. Yet, they remain invisible, undervalued, and unevenly distributed. Women are disproportionately burdened by unpaid care and domestic work, resulting in time poverty, drudgery, and ineffective participation in the labour market.

Women also constitute a significant proportion of the paid domestic workforce and are often paid only minimum wage. The drudgery of unpaid care and domestic chores, and even paid care work, have resulted in subtle, and yet very powerful barriers to women's economic empowerment. Such barriers prevent the household and the economy from tapping into women's full potential even though women account for most of the paid domestic workforce.

The COVID-19 crisis has yet again proved how central the care economy is to society. The post-COVID-19 recovery offers an opportunity to make the care economy a key driver of a more inclusive and equal society.

Strategic investments informed by quality evidence can significantly contribute to addressing vulnerabilities in the care economy sector by rewarding and formalizing care services and domestic work. They can also contribute to reducing and redistributing care responsibilities. Estimates show that increasing investments in the care economy can create 475 million jobs by 2030 and help meet SDG targets related to health, education, and decent job creation.

Against this background, the panel discussion aims to dwell on various aspects such as (indicative):

- 1. The state of the private sector in the care economy and challenges thereof
- 2. Opportunities social finance to support enterprises in the care economy
- 3. Support structures that exist or need to be put in place to enable such investments

REVISITING INVESTMENT PRIORITIES IN THE WAKE OF CLIMATE CRISIS

View the session here

While climate finance reached record levels by 2017-2018 (crossing the USD half-trillion mark for the first time), it still remains far behind what is needed to keep global warming below 1.5 °C. The estimated investment required to achieve the low-carbon transition ranges from USD 1.6 trillion to USD 3.8 trillion annually between 2016 and 2050, for supply-side energy system investments alone (IPCC 2018). The Global Commission on Adaptation (GCA 2019) estimates adaptation costs of USD 180 billion annually from 2020 to 2030. During this period, public finance represented 44% of total commitments, largely driven by domestic, bilateral, and multilateral development finance institutions (DFIs). 56% of the private finance was mostly driven by non-financial corporations, although their share saw a declining trend.

In 2018, less than 1% of assets in the world's largest 100 pension funds were invested in low-carbon solutions. Only 15% of these funds had a policy in place which omitted fossil fuels in some way from their investments, and 65% did not have any kind of formal climate policy. A recent survey conducted of 104 asset managers globally, showed that 40% of asset managers are still not engaging in climate change. The 60 largest commercial and investment banks have collectively financed \$3.8 trillion in fossil fuel companies between 2016 and 2020, five years since the Paris Agreement was signed.

While many in the investment community have made significant strides when it comes to divesting from fossil fuels, investing in low-carbon solutions, and disclosing financial risks emerging from climate change; it is evident that a tectonic shift is needed in investment priorities and trends to achieve the globally agreed climate goals. This session will help the audience understand the factors that will be instrumental in driving this shift going forward.

#WomenAtSankalp has been one of the key initiatives that have become a mainstay of the summit over the last few years. It stems from the recognition that women are often under-represented in convenings and a dedicated approach is needed to be inclusive. At an overall level, we are committed to gender-balanced panels and representation across all of our sessions at the summit. We have a no "manel" policy that we pay strict attention to.

We also recognised the need that women need to network and engage more specifically with each other for multiple reasons, including to network at a professional level as well as at a leadership level. Very often the time to network is limited for women, and the challenges that women face across the impact ecosystem are unique and can be often overlooked. Women can inform, lead and solve the challenges other women face.

Every year at Sankalp summits, we create dedicated space and time for women to come together to foster stronger networks amongst women leaders in the impact ecosystem.

In the 2021 Global Summit, we convened a workshop on "Decolonial Feminists" that was guided by Tanya Mckenzie an educator & researcher from Zimbabwe, along with Malvane Timbane, a young woman from South Africa who grew up in Soweto and is currently a development professional. This workshop was designed to be self-reflective & interactive, introduce the concepts: coloniality of being (identity), coloniality of hierarchies (gender), and coloniality of knowledge, decolonial feminism, and to introduce a space for a creative end to the workshop.

Decoloniality of mind can be very liberating, although it requires a brave and honest self-examination for this reason participants will be encouraged to engage with their emotions, their visceral instincts, and delink from prescribed texts. The workshop ended with a creative expression as we step into 'being' women delinking from the colonial matrix of power.

The workshop was attended by 40 women from across the world and was **uncomfortable at times**, fun at times, but ultimately reflective and transformative.

We hope to continue this initiative every year to allow women to network at Sankalp in an informal and safe setting.







3RD CAIF CONCLAVE

Enviu, Circular Apparel Innovation Factory (CAIF), and IKEA Foundation have partnered to set the ground for building a new circular textile waste model in India that will help recover and reclaim value from textiles waste while unlocking green jobs for the waste workers who are one of the most vulnerable and underserved communities.

This was announced at the CAIF Conclave Opening Plenary at the 13th Edition of the Sankalp Global Summit. The CAIF Conclave at Sankalp hosted 4 sessions with 23 speakers.

Speaking at Sankalp Global Summit 2021, Vivek Singh, Head of Portfolio - Employment and Entrepreneurship, IKEA Foundation, said, "There is huge potential in the textile waste sector not only to become more sustainable but also to create better livelihoods for a large number of people at the bottom of the pyramid. We believe that green and circular entrepreneurship in India's textile waste sector offers an opportunity for vulnerable workers to lift themselves out of poverty while protecting the planet.

In the first phase of the project, Enviu and CAIF will seek partnerships with manufacturers, brands, and innovators to scale and replicate solutions to manage textiles waste; as well as NGO's and other civil society actors to build skills and capacities amongst the waste workers in India.

Venkat Kotamaraju - Director, CAIF, said in a statement, "The scale and scope of the problems being addressed by the textiles and apparel industry globally demands an active investment into and setting.

Opening Plenary: Sustainable Business is Good Business



In the welcome address, our Anchor Partners - ABFRL & DOEN Foundation set the context for the Conclave and highlighted the need for an ecosystem-driven approach to accelerate the textile and apparel sector's transition towards a circular economy.

The fireside chat segment highlighted the multiple dimensions of responsible consumption, responsible design, and responsible production that may ensure sustainable value creation in the textile and apparel industry.







Reimagining Jobs & Livelihoods in the Textile Industry

- Industry 4.0 marked by automation, adaptation, agility cannot be achieved with women being left behind. Women must be trained for these soft and hard skills that helps them to prepare for new jobs in digitisation, 3D printing, and the likes
- Textile waste is emerging as a potential area for creating opportunities for workers. Jobs and related skills in the repair, maintenance, sorting, collection, resale of clothing are becoming more relevant in the transition to a circular economy.
- Waste workers should not be paid only for the material they are collecting, but instead for the environmental service they are providing.
- Conversations have to move beyond the 'minimum income' and instead, look at the living wage to ensure that every human being is entitled to a life of dignity.



The Business Case for a Circular Textiles Economy

- Circularity should not be deemed as something happening in one corner of the business, it should be the core of the business. It is core for meaningful growth which can help brands transform themselves.
- Circular economy is a well-known concept however it is essential for funders and brands partners to support circular entrepreneurship to scale such solutions. It is imperative to launch circular business models that have both environmental and social benefits and can uphold the lifestyle benefits of products.
- For circularity, stakeholders not only need to develop vertical collaborations but also horizontal relationships with peers, because there is so much to learn from collective engagement.







The Private Sector's Role in Getting to Net-zero

- The challenge lies in driving the triangle of providing superior products that are sustainable and affordable to the consumer. The need is to think of a reduction in energy consumption and adoption of renewable energy simultaneously that can help achieve the net-zero targets.
- There are no low-hanging fruits here and it requires fresh thinking at three levels i.e. the idea level, the ecosystem level that will allow commercialization of the idea, and lastly government and policy level which will make the idea viable across the board.
- Many large manufacturers are shifting to renewable sources of energy despite the existing fossil fuel subsidy. As a manufacturer, it is equally important to ensure that the entire supply chain is moving in the direction of net-zero.

VOICES FROM THE GROUND

This year, as a part of the CAIF Conclave we were very proud to include the voices of workers from the textile and apparel industry in our convening.



Fatema, a garment manufacturing worker from Bangladesh shared with us her journey from being an operator to now having been promoted to the position of a supervisor. With the support of BRAC's supervisor training program, Fatema has benefited immensely. Since becoming a supervisor, Fatema is now financially independent and aspires to be an Assistant Production Manager in the next five years.

Ambika, a waste worker from Bangalore shared with us her journey from starting waste picking at 16 to now running a Dry Waste Collection Center. With the support of Hasiru Dala, Ambika has been able to create a livelihood from waste collection and gotten this centre to help recycle about one ton of waste per day. She adds that the efforts of waste pickers save the local corporation almost 83 crore rupees.





Madhuri, a Self Help Group worker from Charoti, Maharashtra shared with us her experience in finding work close to her home and setting up the Mahalakshmi Women's Self Help Group. With the support of the House of Anita Dongre, the SHG Center receives orders, and the group of 40 women has gained livelihood opportunities to earn income and support their families. Madhuri, in her story, shares how she is now ready to learn all sorts of work and even become a line supervisor.

This was the second edition of one of India's unique unlisted mid-market companies conferences. 































SANKALP GLOBAL AWARDS 2021

Despite significant progress in recent years, particularly on access to electricity, we are not on track to meet Sustainable Development Goal 7 (SDG7) to deliver universal access to energy by 2030. Almost 3 billion people remain without access to clean cooking. Without sustained efforts, 650 million people will still be left without access to electricity in 2030, and 9 out of 10 of them will be in sub-Saharan Africa. This affects all development goals, not just SDG7 as poor access to energy jeopardizes healthcare and education provisions, quality of life, gender equity, livelihoods, and much more besides. 






EXHIBITIONS AT SANKALP
